Under Section 316(b) of the Clean Water Act Congress has mandated, "316(b) requires that the location, design, construction and capacity of cooling water intake structures reflect the best technology available for minimizing adverse environmental impact." Section 316(b) applies to power plants (and manufacturing facilities) that are a point source discharge with the capacity to withdraw greater than 2 million gallons of water per day from an adjacent water body and use at least 25 percent of that water exclusively for cooling.

These facilities must use "best technology available" (BTA) to meet minimum standards of reducing rates of Impingement Mortality – fish and shellfish killed on intake screens – and Entrainment – fish eggs or larvae drawn through the cooling system. Which technologies meet BTA standards for the most part is left to state regulatory agencies.

Compliance with 316(b) carries significant impact on facilities using cooling water, with potential cost and plant efficiency paramount. Solutions for 316(b) compliance vary widely in this regard. Plants operating under a NPDES or state SPDES permit may be required to test and implement 316(b) compliance technologies to determine their effectiveness and fit for their budget and operational parameters.
